VI. SCHOOL PRINCIPAL'S REPORT

Brian Grossenburg reported the following:

A. Estimated Count Report

Principal Grossenburg informed estimated count is at 73 and encouraged the members to refer any students who are interested in enrolling as the school needs about 45 students to reach the enrollment numbers for the fall. Principal Grossenburg stated there are many new students attending summer school.

Jesus G. Figueroa asked what the age limit is for a student. Principal Grossenburg replied the age limit is 16-22.

B. Overview of House Bill 2862

Principal Grossenburg informed the board; currently there is a house bill that is moving thru legislation. If the school was to go back into a pandemic situation, schools will have the flexibility to adjust class period lengths, calendar length and the amount of hours required to achieve credit courses and the amount of hours needed to receive funding based on school calendar, school period length and school day lengths.

The house bill also indicates the school would receive a 5% reduction of funds if 50% or more of the instruction is thru remote learning and therefore it would create a challenge for the school. Principal Grossenburg questioned state if the 50% is in the legislation, does it mean instructional time or is it based on students. Principal Grossenburg has received no guidance as the house bill is still under legislation.

Current Pandemic Information As of June 3, 2021



Area School Information

Yuma School District One

Starting with summer sessions, students and staff will not be required to wear face coverings. The district is still recommending face coverings for staff that have not been vaccinated.

Yuma Union High School

Currently the superintendent has issued directive where face coverings are optional for summer school, but are strongly recommending face coverings when social distancing is not possible. The district board plans to make board decision at the July board meeting.

Aztec High School

The school follows directives established by the courts. Currently the courts are still mandating masks so at this time the school is maintaining the policy of mandated face coverings. The school will look at the issue when the chief justice of the courts makes a decision. Steve Pallack, school principal, is recommending continuing the mandatory face coverings.

Crane School District

Starting June 1, face coverings will be optional and will be providing in-person instruction in SY2021-2022.

Somerton School District

At the start of SY2021-2022 will make face coverings optional and return to in-person learning with the provision that schools can implement remote learning and mandated face coverings if a resurgence of the pandemic appears in the community.

Information From Arizona Department of Education

Web posting still remains the same as appeared on March 1, 2021

Universal and correct use of masks is the top mitigation strategy for safe in-person learning as recommended by the CDC. While not mandated by the state, we strongly encourage school leaders and administrators to mitigate the spread of COVID-19 by requiring masks on school campuses, on school buses and during school-associated activities by all students, faculty, staff, contractors, and visitors.

Information from CDC

Fully vaccinated people can resume activities without wearing a mask or physically distancing, except where required by federal, state, local, tribal, or territorial laws, rules, and regulations, including local business and workplace guidance.

In general, people are considered fully vaccinated: ±

- 2 weeks after their second dose in a 2-dose series, such as the Pfizer or Moderna vaccines, or
- 2 weeks after a single-dose vaccine, such as Johnson & Johnson's Janssen vaccine

If you don't meet these requirements, regardless of your age, you are NOT fully vaccinated. Keep taking all precautions until you are fully vaccinated.
