VI. SCHOOL PRINCIPAL'S REPORT

Principal Brian Grossenburg reported the following:

A. Student Council Presentation: Changing School Mascot from Hornet to Honey Bee

Student Council Vice President, Natalia Soto and Treasurer, Keyven Miranda presented a PowerPoint proposing to change the school mascot from a hornet to a honey bee. PowerPoint is attached.

B. Enrollment Summary

Principal Grossenburg provided the following information regarding enrollment:

- Based on the apportionment date of September 23, 2024, the school will be paid based on 87.1 students
- Based on the current 40th day, the average daily membership occurred on September 26, 2024, the school met the benchmark of 90 students
- The average daily membership was at 90.325
- The 100th day will occur on January 14, 2025 and the average daily membership is projected to be at 96.1477 students
- On the other hand 6 students will be graduating this week and if they are not replaced it may hurt the schools average daily membership
- There are about 3 to 4 students in the pipeline

Michael J. Sabath asked how often does the school hold graduations. Principal Grossenburg replied, the school graduates students through the whole year. Students can accumulate credits during any time of the school year because of Edgenuity. Dr. Sabath also asked if the students that graduate early in the year still go through graduation at the end of the year. Principal Grossenburg replied yes.

Jesus G. Figueroa asked if Edgenuity is strictly for students that work from home or is it for everyone. Principal Grossenburg replied any student who desires to use the platform can have access to it.

C. Summary of Changes to the Student Handbook Related to School Safety

Principal Grossenburg stated over the past month a lot of the schools have been targeted by school threats. The Educational Opportunity Center Charter High School has been fortunate enough not to be one of those schools. Principal Grossenburg thanked the students and staff for staying vigilant during those times. Staff did find some weaknesses in the school's procedures. Therefore staff is proposing changes to the student handbook related to school safety.

Principal Grossenburg presented the proposed changes to the student handbook related to school safety. Proposed changes are attached.

Michael J. Sabtah asked what kind of reaction is anticipated from the students with respect to their cellphones. Principal Grossenburg replied some students will support it and others will not. The school may lose 2 to 3 students because of the changes.

Jesus G. Figueroa stated he agrees with the proposed changes as cell phones tend to distract people. These changes are very normal and good strong regulations that should be in place.


Proposed Changes to Student Handbook Related to School Safety

Proposed Changes to Student Handbook Related to School Safety				
Requested Change	Impact to School Safety			
1. No student will be permitted to make a phone call through the use of a cell phone during class hours. Checking the cell phone for missed calls and text messages during class hours will only occur with staff or administrator permission.	Cell phone use has been the primary source of school threats within the past month. Partially limiting the use of cell phones during instructional times provides greater monitoring of cell phone use and still allows students and families some form of connection beyond the use of school phones.			
2. Students referred to school administration for misconduct or potential violations of school policy will be required to temporarily give cell phones to a school administrator or designated staff person. The student will be offered the use of a school phone to contact parents or guardians either prior to an incident interview or following an incident interview. School staff have the right to establish a time limit for the phone call. Students must politely terminate the call within a short period of time. The school administrator or designee will return the cell phone to either the student, parent, or guardian at the conclusion of the interview or investigation. If the interview or investigation has not concluded at the end of the school day and all discussions with the student, parent, and guardian have concluded for the day; the cell phone will be returned to the student, parent, or guardian.	Cell phone use has been the primary source of school threats within the past month. Temporarily preventing access to the cell phone prevents students with the ability to use the cell phone to disrupt learning and school operations; or to do malice to other students or staff.			
3. Students will not have access to cell phones during events where school is operating at an awareness level of shelter in place.	Cell phone use has been the primary source of school threats within the past month. Student cell phone use during shelter in place significantly decreases the chance of success of shelter in place practices. Without the right for staff to search the contents of cell phones without permission, causes an increase in the ability for students and aggressors to collude and plan events that disrupt or will cause harm to other students or staff. In addition, student cell phone use causes unwanted attention to rooms during shelter in place. Next, students in the use of cell phones are distracted from safety and emergency response directions being given by school staff. Also, student cell phones hamper rumor control which delays public safety personnel response.			
 4. Students will not be allowed to enter other classrooms without written permission from an administrator or designee. 5. Students will not be allowed to leave a classroom without permission from the staff in 	Students with intent to disrupt or pursue malice towards other students has begun to become more prevalent after the school threats. 


4 VS. 5 YEAR ON TRACK




COHORT 2026 SEPT PRE-ACT




