VI. SCHOOL PRINCIPAL'S REPORT

Principal Brian Grossenburg reported the following:

A. Enrollment Summary

Principal Grossenburg provided the following information,

- Current Average Daily Membership Enrollment is at 96.26
- 103 students enrolled
- 5% under budget

Principal Grossenburg shared a summary regarding the Arizona State Board for Charter Schools Compliance. Summary is attached.

C. Fall Perception and Performance Report

Principal Grossenburg presented the Quarterly Report on School Improvement Initiatives. Report is attached.

Michael J. Sabath commented, its great news regarding the Cognia Accreditation and the five year graduation rates.

Michael J. Sabath asked what are the most significant factors that we should focus on to make sure that sustains that five year graduation rate and what do you think affects it. Principal Grossenburg replied the biggest initiative has to be attendance. If the school has 103 students, that means about 70% of them are here and 30% are missing. It will have an impact on graduation rate and academic achievement, especially if they're already enrolling in our school. At the beginning of the school year Principal Grossenburg provided a report, where he analyzed the academic achievement levels of students coming in based on what they do with the pre-ACT, and where they are on credits. 94% of our students that enroll at our school tend to be below at least one year or more of where they're expected academic achievement is supposed to be at. One of the reasons students come to us is because their attendance was so poor in their last school that they couldn't maintain enrollment. In Arizona students are withdrawn at 10 consecutive days of absences.

Michael J. Sabath asked, does the school provide any incentive for students to take the ACT? Principal Grossenburg replied yes, they actually run a school wide program based on the categories of the ACT. The school dedicates at least 20 minutes daily to ACT instruction and testing strategies. Each week we give an assessment based on the four main categories of the ACT which is the English language arts, reading, math and science. The school recently started cutting a plan for when our students take the ACT in April. How can we set up a testing environment? And how can we make sure that we get everybody tested instead of avoiding it?
