VI. SCHOOL PRINCIPAL'S REPORT

Principal Brian Grossenburg reported the following:

A. Enrollment Summary

Principal Grossenburg provided the following information,

- Enrollment is at 80.3
- The academic advisor has been actively attending community events
 - Participated in two events with the Regional Center for Border Health
 - o Attended one additional event with another local agency
- Nidia Herrera hosted a tour for four Yuma Union High School District dropout prevention coordinators at the Youth Services Department
 - The coordinators were impressed and interested in partnering with our school
 - They plan to involve their students and communities in our future events
- Youth Entrepreneur Training is on November 3, 2025 and will be hosted by Arizona Western College and the Small Business Development Center
- Movie Night is on October 23, 2025 and is open to the community
- Will continue promoting our activities on social media, the school is focused on maintaining strong community visibility and engagement

B. Peer to Peer Mentoring Program Update

Principal Grossenburg provided the following information,

- The program started the school year with 8 peer mentors; 2 resigned due to work and internship commitments
- Mentors are supporting 22 students with high absenteeism
- Active mentoring began only a few weeks ago, so impact on attendance is not yet measurable

C. 11th Grade Short Cycle Assessment Summary

Principal Grossenburg provided the following information,

- Each week, the school gives a short cycle assessment aligned to the ACT
- Assessments focus on specific content chosen based on school data showing areas of weakness and high likelihood of appearing on the ACT
- The assessments are short: 2–3 questions per subject (math, english, reading, science)
- Science is still assessed but won't count toward the school grade this year
- 11th graders are tracked closely since their performance affects school accountability
- Currently, 13 11th graders are eligible for the ACT, 6 of 13 are meeting weekly benchmarks
- Quarter 1 content covered, Language: commas, tense consistency, Reading: key ideas, word choice, Math: mean, factors, fractions, percents
- The goal is to help students master high-probability ACT question types, improving overall ACT performance
- Additional concepts will be added as students reach mastery

D. Emergency Operation Plan Update

Principal Grossenburg provided the following information,

All necessary signatures for the Emergency Operation Plan have been obtained

- The plan is an action item for the board to consider today, once approved, staff training on the updated plan will begin soon
- Shout out to Ms. Adriana McBride for coordinating everyone, including the Yuma County Health Department
